Criteria for Vendors: Georgia Grown Farmers Showcase

All Vendors must comply with all requirements set forth by the Georgia Dept. of Agriculture. All Criteria outlined below will be enforced and subject to auditing at any time.

All vendors must carry general and product liability insurance.

No reselling allowed without prior permission. At minimum, 50% of all produce or products sold by vendor must be made or grown by that vendor.

All vendors must maintain a list of ingredients and sources on site and must be able to provide upon request by GDA.

Prices must be clearly posted at all times.

All stands must be kept in a clean and sanitary condition. Each Farmer is responsible for cleaning stall area when day is over. If food samples are being given out, each vendor must provide sampling materials such as toothpicks, utensils or cups and provide trash receptacle for the disposal of any sampling materials.

All tables, canopies, tents, etc. must be secured and should not cause a tripping hazard to customers.

FARM PRODUCTS:

- All Fruits and vegetables must be Georgia Grown.
- Cheese or other value-added products from mil must be manufactured in a licensed facility.
- Meat raised and processed in Georgia. Must be processed in a GDA or USDA licensed facility.
- Eggs from local fowl- no resale of another Farmer's eggs is allowed. Must have Candler's Certificate or Food Sales Establishment License.
- Honey from Local Hives only

PREPARED FOOD PRODUCTS:

- All foods must be prepared in a kitchen inspected or licensed by the Department of Agriculture of USDA
- All products must be made by you or your staff (i.e.: if you sell muffins, they must be made from scratch)
- If packaged, all vendors must have product labels that include all ingredients and allergen declarations.
- Use of local farm ingredients is strongly encouraged.
- All vendors must submit a list of ingredients and sources.

FLOWERS, PLANTS, AND TREES:

- All flowers, plants, bedding plants and trees must be from a Georgia farm or greenhouse.

ARTS AND CRAFTS:

- All crafts must be made by the vendor-no reselling
