



- Did you suffer at least a 15% production loss?
- Are you applying as an:
 - Individual
 - General Partnership
 - Joint Venture
 - Sole Proprietorship
 - Corporation
 - Limited Partnership
 - Limited Liability Company
 - Revocable/Living Trust
 - Irrevocable Trust
 - Estate
 - Charitable/Tax Exempt Organization

Note: entities are required to list the member names and shares

- What is your name or the name of your operation?
- What is your Tax Identification Number?
- What is your Gate Card Number?
- What is the physical location of the farm? (both)
 - Address
 - Latitude and Longitude
- What is your USDA Farm Number?
- How do you have possession of this farm?
 - Ownership
 - Lease Contract
- How do I prove my interest in the farm suffering a loss?
 - 2024 Tax Assessment
 - Deed
 - Lease Contract

How do I find the Latitude and Longitude of the parcels
suffering a loss?

1. Go to google.com/maps
2. On the "Search Google Maps" line, type the address of the disaster affected property OR select the property on the map.
3. Right click on the location of the property
4. An information box will display the latitude and longitude

- What must I report in order to assess my loss?
 - Number of bushes less than 4 years old on 09/24/2024
 - Number of bushes 4 years and older on 09/24/2024
 - Number of replacement bushes less than 4 years old
 - Number of replacement bushes 4 years and older
 - Interest in each parcel
- What documentation do I need to prove loss of blueberry bushes?
 - HBG-02
 - Acreage reports
 - Crop insurance records
 - Invoices for replacement bushes
 - Bush removal receipts
 - Photographs
 - Other documents you believe will assist in assessing your loss

You must maintain the farming operation, or continue to work or otherwise engage in or participate in an agricultural operation through December 31, 2027.

You are required to purchase blueberry crop insurance or Noninsured Crop Disaster Assistance Program (NAP) coverage equal to or greater than the 60/100 level of coverage (or equivalent) for the first two consecutive crop years when coverage is available after receiving payment. Contact a crop insurance agent or the Farm Service Agency for more information.

Failure to meet these requirements will require you to refund the money you received to the Georgia Department of Agriculture.

Documentation listed here is NOT comprehensive.
Applicants may submit additional documentation they believe will support their application.
